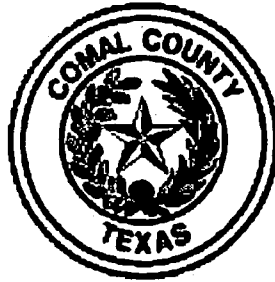

**ORDER OF COMMISSIONERS COURT OPENING A
TEMPORARY BRANCH EARLY VOTING LOCATION AT
THE CRRC-SATTTLER ACTIVITY BUILDING**

WHEREAS, Section 85.061(a) states that in a countywide election wherein the County Clerk is the early voting clerk under Section 83.002, an early voting polling place shall be located at each branch office that is regularly maintained for conducting general clerical functions of the County Clerk, except as provided by Subsection (b). Texas Election Code Section 85.061(a).

WHEREAS, Section 85.061(b) states that in an election in which a temporary branch polling place is established under Section 85.062(a)(1) or (d), the commissioners court may provide by resolution, order, or other official action that any one or more of the County Clerk's regularly maintained branch clerical offices are not to be branch early voting polling places in the election. Texas Election Code Section 85.061(b).

WHEREAS, the Comal County Fire Marshal has inspected the Sattler, Texas Branch of the County Clerk located at 106 Oak Drive, Canyon Lake, Texas and has deemed said office not suitable for use as a permanent branch polling location due to its small size.

WHEREAS, the CRRC-Sattler Activity Building located at 1941 FM 2673 Sattler, Texas is suitable for use as a Temporary Branch Early Voting Location pursuant to Chapter 85 of the Texas Election Code.

ORDER OF COMMISSIONERS COURT OPENING A
TEMPORARY EARLY VOTING LOCATION AT
THE CIRCULAR ACTIVITY BUILDING

WHEREAS, Section 8-100(a) states that in a countywide election when the County Clerk is the only voting place, an early voting place shall be located at such place which is properly maintained for conducting general election business of the County Clerk, except as provided by subsection (b). (Section 8-100(b))

WHEREAS, Section 8-100(b) states that in an election in which a temporary branch polling place is established under Section 8-100(a)(1) or (4), the commissioner's court may provide by resolution, order, or other official action that any one or more of the County Clerk's regularly maintained branch polling places may not be used as a temporary polling place in the election. (Section 8-100(b))


WHEREAS, the County Clerk has inspected the Circular Activity Building at 100 East Taylor Street, Chicago, Illinois, and has determined that it is suitable for use as a temporary branch polling location due to its size, location, and accessibility.

WHEREAS, the Circular Activity Building located at 100 East Taylor Street, Chicago, Illinois, is suitable for use as a temporary branch polling location pursuant to Chapter 8-100 of the Illinois Code.


NOW THEREFORE BE IT RESOLVED, that the Commissioners Court of Comal County, for all purposes intended by Chapter 85, Subchapter C of the Texas Election Code as well as any other applicable law, hereby duly declares the CRRC-Activity Building located at 1941 FM 2673 Sattler, Texas is a suitable Temporary Branch for Early Voting and shall be open for early voting during the November 2009 Constitutional Amendment Election on October 28, 2009 from 10:00 am until 5:00 p.m.


This Order shall be in full force and effect on the date this Order is recorded and approved.
